MarkK – Covered Bridge is not covered by insurance for floods. Inspectors have been there and will return with an estimate. Preliminary estimate is \$100,000 in damage. Siding is wood shiplap Poplar. Structurally the bridge is fine. Without siding it should not have foot or vehicle traffic. That's why it is remaining closed. The County has a line-item fund for the Covered Bridge that has about \$10K in it right now. Brad Speer has contacted FEMA to see if there is

any money available. The bridge will eventually be repaired. It's just a matter of how much it will cost. Terri gave MarkK over \$700 that was collected at DQ so far in 21 days. Wednesday, August 4th and Thursday, September 9th are now designated as Covered Bridge Sponsor Nights at Westport Dairy Queen.

Ila suggested that we look to see if there are any Covered Bridge societies out there that may have \$\$ to help with our bridge repair.

JoAnn Smith gave an update on Suff-n-Things. They have expanded hours. Also the "swap meet" that used to be at the Westport Park has now moved to the Methodist Church parking lot. Grand Opening of the Swap Meet will be Saturday, August 7<sup>th</sup>.

Bryan Gatewood introduced Dave Purcell the new Director at Southeastern Baptist Youth Camp.

Ila Cottone made the motion to sponsor The Race at Southeastern Baptist Youth Camp at \$100. 2<sup>nd</sup> by Terri McGrath. Motion Carried.

## Crier Improvement Committee 7/21/2021 4:30PM

Bryan reported that the August / September community calendars were transmitted to Sandra via email on 7/12/2021. The actual cutoff date was 7/10/2021. Sandra said she would see what she can do to fit the calendars onto 1-page. Also new content has to come in 4-page increments. Bryan shared this with the improvement committee.
